\_\_\_\_\_ In the event a student does not wish to continue classes, a parent/guardian must give **one** month notice in writing. If notice given in the middle of the month - you **will** be charged for the following months fees.

\_\_\_\_\_ I am aware that proper dance attire must be worn to classes. Failure to wear the appropriate clothing will result in my dancer sitting out of class that day.

\_\_\_\_\_ Failure to pay fees on time will result in a 10% late fee being applied to your account. Arrears greater than 30 days will result in immediate removal of the student from class.

## Competitive Classes

Competitive classes are a privilege. We expect all of our dancers to be respectful and to attend and participate in these classes; missing classes affects both the teacher and the other students in the class. Missing more than **3 classes** per semester (without informing the office) will result in the dancer being pulled from Competitions. The dancer will still be eligible to dance in the year end show. *Fees will not be refunded.*
